My name is Tom Kaszynski and my wife Susie and I live at 610 Devon Drive just across the street of the proposed rezoning

When we found the few lots that were available in this area we did our homework and even though across the street was vacant at the time we knew that some day there would come a time when someone would build on those lots being zoned as they were. We had no problem with that.

The problem we have is someone coming in and buying that parcel and then thinking "HEY if I can get it rezoned then I can make a boatload of money and just walk away"....and also thinking "Ive got connections to make this happen". This property was sold on Oct 14th of this year and here only a few months later the new owner already has a plan...for 38 more homes? Didn't he know that it was zoned for one house/acre or was there a hidden agenda behind the entire sale? Sure makes you wonder doesn't it?

The entire thought of having this property rezoned is crazy and shouldn't really even be considered. Why even have zoning laws if all it takes is someone coming in and thinking " we can make a lot of money here"

Why not just have the owner build his houses as it is zoned now?

I've driven thru many mountain towns and this town, my town, has something that the other towns don't have. SPACE. Other nearby towns have houses and people stacked right on top of one another. Please don't make this town like the others.

Once we get to the town limits after being down in the valley there is a sense of calm in us in the fact that we have let the rat race behind and we are "almost home"

Somewhere in the proposal is a statement about wanting to make a "small community". We already have a small community, so why not just build as it is zoned now and join the existing community? We are totally against having the zoning changed
